Review and vote on amendments to FY2024 Budget (25) Jones, Alvarado

• Introduction to tonight's discussion:

Rene: Three amendments have been seen for a first reading.<sup>3</sup>

Point of information: do we need to talk about the requirement for the two readings?

Rene: There is a proposed amendment to one of the amendments, but no need to suspend two readings today.

• <u>First Bill</u>: Affinity Partnership Fund (APF) VP of Finance Nakisha Renee Jones

The general goal of the APF is to help increase the amount of funding for affinity groups in order to foster more collaboration among them and G12 schools. There are multiple pieces, but all involve moving around money within the ideal council budget that already exists.

First increase is the empowerment fund: aka how groups get their annual budget.

Second is increasing funding to affinity partnership fund by 8000 to help groups have a way to contribute into the G12 matching funds.

Overall, moving this money would reduce the council budger form 26k to 15k, but is they money is still used within IDEAL. Questions?

Point of information: Given the amendment to the amendment, is this the first reading of the new amendment?

Assembly Member: My understanding is that the amendment is about a governance issue rather than money, I defer to ruling of the chair if its appropriate to be attached to a budget amendment. If this requires a second reading or not depends on that.

Defer to Michael. Michael reads it out loud, the chair will decide if its governance or finance.

The intent is to make sure old rules established still apply to the new fund. Keeping consistency between IPF (interschool partnership fund) and APF.

Point of information: Could we see the actual clauses that are resolved?

Screen sharing the bill.

Chloe: Note number 3 fundamentally changes how the APF would work.

Assembly Member: For context on procedural matters only: to alter the governing documents of the Financial Advisory Board (FAB) the constitution of GAPSA would need to be amended on who is part of FAB and whether they are voting or not voting. FAB and IPF are subject to dual jurisdiction (GA and G12) so both entities would need to approve. With the new amendment there are new steps which need to be done before we can vote.

Point of information: Chair rules that amendment is out of order.

Appeal to the ruling of the chair that this is out of order.

Motion to appeal chairs ruling. No second. Motion does not go.

Point of information: Would money come from G12 funds or affinity funds?

Assembly Member: Defer to Nakisha, but it should function just like any other IPF scenario. Each investor decides how much they want to put in. If sourced from G12, GAPSA will match, if sourced from affinity group it would come from the affinity fund.

Currently, are the funds from the G12 matched by GAPSA if G12s are working with affinity groups? Yes, but only if there are two G12s involved.

Correction from IDEAL Council Chair Chloe Ricks: This bill does not deal with a G12 partnering with an affinity group to receive fund matching. This is just affinity group to affinity group partnership fund matching.

Chair brings us to 5 minutes for debate

Point of info: This conflicts with constitution.

Motion to remove that part of the resolution.

Assembly Member: The text is non-binding. All we would do is be bound by the numbers if we approve this today.

Motion withdrawn.

Point of information: What is this fund classed as? I.e. what rules will it be subject to?

This is being framed as a pilot fund so it will be subject to those GAPSA rules and co-managed with IDEAL.

Motion to end debate and move to a vote. Seconded. All in favor. Motion is carried

Is there a motion to vote on the amendment text?

Motion to call the vote. Seconded. All in favor. Motion is carried

Vote is called, majority has it and in the eyes of the chair the amendment has passed.

• <u>Second Bill</u>: Council Development Funds <sup>4</sup>

Director of Budget Rene Alvarado

The goal of this bill is to give research and professional councils \$5000 into a professional development fund. This was taken away last year because of the overall budget reduction. Idea behind taking away this fund is that councils will work with operations to get any needed funds for development type activities (food, retreats). This amendment takes 10k from reserves for these two line items. Some money will also go into the bonus fund to incentivize good budget practices.

Joe: Move on to Q and A. Any questions?

Jenny: How are the funds envisioned to be used? What classifies usage of this money?

Rene: Reminder that the amount for this was previously around 10k, but defer to Ludwig.

Ludwig: RC hosts small group coffee dates with constituents. It's essentially a discretionary fund. RC reviews grants which is work, serve dinner. We provide extra services only to research students rather than the whole GA, which is harder to justify using GA funds for.

Assembly Member: So to be clear, its for the people sitting on the councils?

Ludwig: No, its for research students in general.

Assembly Member: This amendment combines the Academic Event Fund with Research council development fund? Why?

Rene: We're not considering that we're only considering the amendment text on the screen.

Assembly Member: Move to strike line item 6.6 consolidation out of the bill. Seconded. Move on to debate

Point of information: What was the intention of consolidating in the first place?

To allow for greater flexibility.

Ludwig: AEF has always been used. Moving money to places like individual grants from AEF at the end of the year is the goal.

Assembly Member: Why are we allocating this when the Academic Committee spent over 150% of their budget last year?

AEF doesn't supply AC. Supplies more niche symposiums and other things

Assembly Member: Objection to the two line items

Ludwig: it is fine, but if they are not consolidated we will need more amendments later on especially with further need for provost approval.

Nakisha: More context is that even though money was awarded for AEF, it got billed out of student group event fund, which made it look like AEF was under used. More flexibility means easier transfer later if it is underutilized.

Debate is closed as ruled by the chair. Reminder that the motion is to strike out the consolidation of two line items. All those in favor.

Joe: Aye's have it, amendment to amendment passes and the line item consolidation is struck.

Assembly Member: I'd like to propose an amendment to include the clauses to the resolved section of the bill.

Out of order since it would need a first reading and ten day notice. Withdrawn.

Assembly Member: Does anyone else get a development fund?

Nakisha: there are places where funds can be used for committee meetings.

Assembly Member: Side questionL I'm wondering why the floor amendment was told they needed ten day lead time, when the previous amendment to strike lines from the bill did not?

The difference was the old was pertaining to content in the bill that wasn't moving money around, new one is moving money around that needs 10 day notice.

Assembly Member: If those funds are available, why does RC need this separate line item?

Nakisha: They aren't available to PC and RC. This brings equity to them.

Joe: Final points of debate?

Assembly Member: We strongly urge to pass so that RC doesn't have to keep bringing stuff to this body.

No objections. Call the question (vote). Majority in favor, in the eyes of the chair the amendment passes.

• <u>Third Bill</u>: Reduction of Provost Contribution Director of Budget Rene Alvarado

Rene: This amendment reduced the GAPSA provost award fund line item in the budget from 90k to 63k.

Entering Q and A.

Point of information: The overall budgets were given by the provost?

Rene: Yes, we were given 2.315mil later. 2.342mil was voted on in April. This just needs to get stamped.

Motion to end Q&A and move to debate. Seconded. All in favor. Motion is carried

Motion to end debate and move to a vote. Seconded. All in favor. Motion is carried. Vote is called, in the eyes of the chair the amendment is passed.

**Discussion of Bylaw and Constitutional Amendment processes (10)** Chair Pro Tempore

- Brief discussion on how amendments are made. Refer to the Constitution and Bylaws, relevant text copied below.
- "This Constitution may be amended by a three-fourths vote of the General Assembly, provided the full text of proposed amendment has been distributed with ten (10) days notice before the final vote. The final, adopted Bill amending the Constitution must be in writing and specify the exact textual changes to the GAPSA Constitution and also an official abstract of the changes made. For amendments adopted in 2023 or later, the count of the vote adopting it, including the number voting yes, no, and abstaining, must be recorded. Upon adoption, the Constitution is republished (1) as revised by the adopted changes, (2) with the official abstract (or full text of the amendment, if no official abstract is adopted by the same three-fourths vote) appended to Article XIII: Amendments, as a new section at the end with a paragraph for each "Resolved" clause or section of the instrument (dropping the enacting word "Resolved"), and (3) with the date of passage and the count of the vote adopting it (yes, no, abstain) appended as a subparagraph of this paragraph (Article XIII(A)(1))." Page 42
- "Upon approval by two-thirds majority vote of the Executive Board and ratification by simple majority of the General Assembly, the Executive Bylaws may be revised." Page 17

[Chair]: The next item on the agenda is the second reading of Bill 99.

[GA 1]: \*Raises hand\*

[Chair]: The chair recognizes [GA 1].

[GA 1 - Author]: I move to adopt Bill 99.

[GA 2]: Second!

[Chair]: It has been moved and seconded that the GA adopts Bill 99. Does [GA 1] wish to be assigned the floor?

**[GA 1]:** Yes. I think we should adopt Bill 99 to make Ollie the Cavapoo the official mascot of GAPSA, because it would make people smile. Also, he is a good boy.

[Chair]: Ok, is there any debate?

[GA 2, 3, 4, 5]: \*Raises hands\*

- GA 2 = thumbs up, GA 3 = thumbs down, GA 4 = fist, GA 5 = thumbs up

[Chair]: The chair recognizes [GA 3]

[GA 3]: I think we should be talking about the University's emergency response to the water crisis last semester, not a dog.

[Chair]: Please limit your discussion to the specific motion, which is whether to make Ollie the Cavapoo the official mascot of GAPSA.

**[GA 3]:** Ok, I don't think Ollie should be the mascot, because a cat would be a better mascot than a dog - a cat is independent and smart, a better brand ambassador for GAPSA.

[Chair]: The information is in the materials that were sent to the GA last week, please refer to those materials. Is there further discussion?

[GA 5]: \*Raises thumbs up\*

[Chair]: The chair recognizes [GA 5]

- Requiring Councils to go to other groups for budgetary needs puts them at an unnecessary disadvantage to not be able to represent their constituents.
